This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Triodos Impact Mixed Fund - Offensive, a sub-fund of Triodos SICAV I, class Z-cap, ISIN: LU1956011941, a UCITS managed by **Triodos Investment Management B.V.**, part of **Triodos Bank N.V.**, www.triodos-im.com. What is this product?

Type: Triodos Impact Mixed Fund - Offensive is an open-ended sub-fund of a Luxembourg SICAV.

Term: The fund has no maturity date. Triodos Investment Management is not entitled to terminate the fund unilaterally.

Objectives: The fund aims to increase the value of your investment over the long term, while seeking to maximise positive impact on society and the environment. The fund has sustainable investment as its objective as set out in article 9 SFDR. The fund mainly invests in equities of companies in developed countries and, to a lesser extent, in impact and other corporate bonds and government bonds. These companies and the proceeds of the impact and corporate bonds must contribute to, or finance projects in, at least one of the following transitions (as defined by Triodos): resource transition, energy transition, food transition, societal transition or wellbeing transition. Issuers that do not meet the Triodos sustainability standards are excluded from investment. Bonds can be issued by corporate bodies or governments. All bonds must be investment grade and denominated in EUR. The return of the fund is determined on the one hand by dividend and interest income from investments minus the costs of managing the fund, and on the other hand by the price changes of the investments, including currency effects

for the equities. The return of the fund depends to a large extent on currency developments and market movements, and to a lesser extent on interest rate developments.

The fund is actively managed. It compares its returns with the Bloomberg Developed Markets Index (75%), iBoxx Euro Corporates Overall Total Return (15%) and iBoxx Euro Eurozone Sovereign 1-10 Total Return (10%), which it does not aim to replicate or outperform. The fund may deviate from the benchmark because it only invests in companies that meet strict sustainability criteria.

Intended retail investor: The fund is available to retail and institutional investors through all distribution channels, with or without advice. The fund may appeal to investors who:

- are looking for a growth-oriented investment combining income and that takes a sustainable investing approach;
- are interested in exposure to a diversified asset mix, either for a core investment or for diversification;
- have a high risk profile and can tolerate significant temporary losses.

Orders to buy and sell shares are ordinarily processed on any day that is a banking day in Luxembourg. Capitalisation share classes reinvest the fund's net realised income, while distribution share classes may distribute it.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that

the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level. The product may be exposed to risks, such as concentration risk, currency risk and interest rate risk. This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

As required by law for your protection, the fund's assets are held with a separate company, a depositary, so the fund's ability to pay out would not be affected by the insolvency of Triodos Investment Management. If the fund is terminated or wound up,

the assets will be liquidated and you will receive an appropriate share of any proceeds, but you may lose part or all of your investment. Your loss would not be covered by any investor compensation or guarantee scheme.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

Given the nature of the underlying investments of the fund and its objective of sustainable investment, a minimum holding period of 5 years is recommended. In general, the fund will invest in listed, risk-bearing assets that are deemed to be liquid in the short term. Investors must be able to tolerate significant temporary losses; added value in the fund will be generated over the longer term. Thus, investments in the fund require a

long-term investment horizon of the investor.

You can redeem your investment daily. To protect the interests of existing shareholders, a redemption gate may be applied. Redeeming your investment before the end of the recommended holding period may have a negative impact on the risk or performance of the product.
