What is this product?

Type: Triodos Energy Transition Europe Fund is a sub-fund of an open-ended investment company with variable capital.

Term: The fund has no maturity date. Triodos Investment Management is not entitled to terminate the fund unilaterally.

Objectives: The fund has sustainable investment as its objective as set out in article 9 of the SFDR. The fund invests primarily in companies throughout Europe that accelerate the energy transition with the prospect of an attractive financial return combined with the opportunity for investors to make a proactive, measurable and lasting contribution to the reduction of CO2 emissions. The Fund invests in equity and/or quasi-equity, such as shareholder loans and preferred capital, and in subordinated debt in qualifying investments. The fund primarily invests in project companies in the European Union, EFTA countries and the United Kingdom that generate renewable energy, reduce energy use, make the energy system more flexible or that enable electrification. In order to enable projects, the fund may invest in projects in the development phase or provide growth capital to privately-owned companies that are active in the abovementioned sectors with the objective of

accelerating their growth. The return of the fund is determined on the one hand by interest income on the loans and dividend income from participations minus the costs of managing the fund, and on the other hand by the value changes of the investments. The return of the fund depends to a large extent on the development of global energy prices, and on policy developments of European and national governments with regard to the (renewable) energy sector. The fund is actively managed, but not in reference to any benchmark.

Intended retail investor: The fund is suitable for the retail and institutional investors who can afford to set aside capital for a long-term period. The investor is aware that they could lose some or all of their investment. Investing in the fund is suitable for the basic investor with a basic knowledge of the relevant financial markets and products as well as for the informed investor. The basic investor is able to make an informed investment decision based on the regulated and authorised offering documentation, or with the help of basic information provided by point of sale.

Orders to buy and sell shares are ordinarily processed monthly. Capitalisation share classes reinvest the fund's net realised income, while distribution share classes may distribute it.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level. This product does not include any protection from future market performance so you could lose some or all of your investment.

As required by law for your protection, the fund's assets are held with a separate company, a depositary, so the fund's ability to pay out would not be affected by the insolvency of Triodos Investment Management. If the fund is terminated or wound up,

the assets will be liquidated and you will receive an appropriate share of any proceeds, but you may lose part or all of your investment. Your loss would not be covered by any investor compensation or guarantee scheme.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

Given the nature of the underlying investments of the fund and its objective of sustainable investment, a minimum holding period of 5 years is recommended. In general, the fund will invest in risk-bearing, most often non-listed, assets that are not liquid in the short term. In most cases, added value in the fund will be generated over the longer term. Thus, investments in the

fund require a long-term investment horizon of the investor.

You can redeem your investment monthly. To protect the interest of existing shareholders, redemption gate may be applied. Redeeming your investment before the end of the recommended holding period may have a negative impact on the risk or performance of the product.
