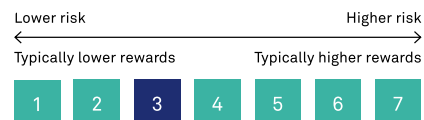

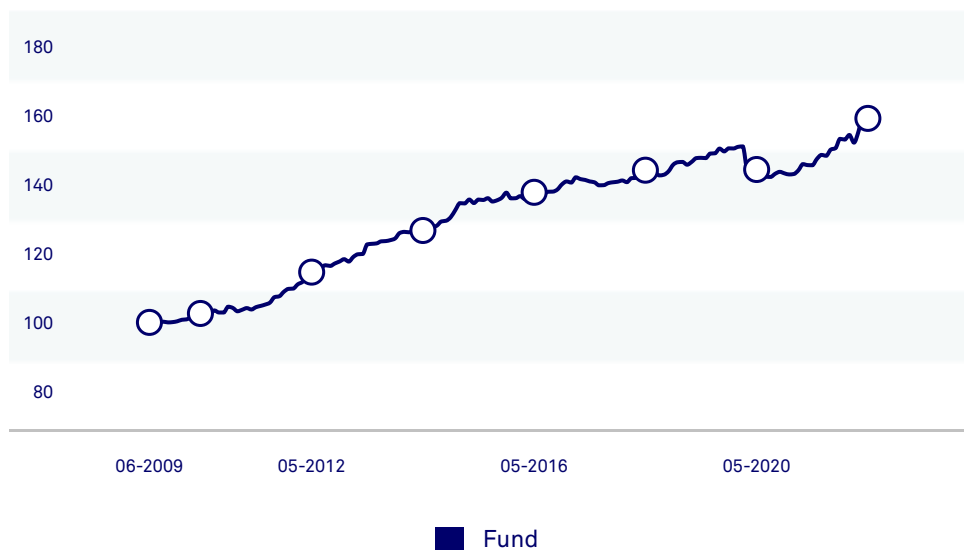

Cumulative Performance Chart

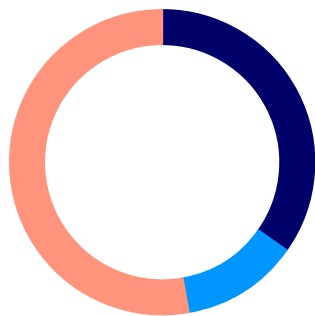

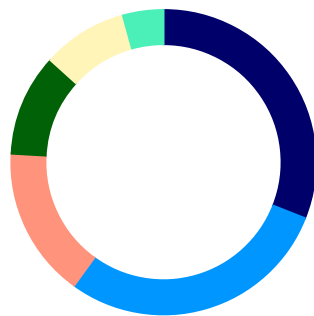
