### **COMPANY OVERVIEW**

CT Environmental Group Limited is a wastewater and industrial water supply services company focusing on industrial wastewater. Its services covers the chain of wastewater treatment, from design and planning, procurement and construction, to operations and maintenance. The Company was founded in 1999 and is headquartered in Hong Kong.

PROPOSALS ADVICE

#### 1 Issue shares to a related party

For

Approval is sought to issue shares through a Subscription Agreement pursuant to which the Subscriber Mr. Gu Yao Kun, will purchase 200,000,000 new shares at a price of HKD 2.575 per share. The Subscription shares represent approximately 3.27% of the issued share capital of the Company and approximately 3.17% of the enlarged issued share capital of the Company. The issue price represents: a premium of approximately 0.98% over the closing price of HKD 2.550 per share at the date of the Subscription Agreement; a premium of approximately 13.54% to the average closing price per share of approximately HKD 2.268 as quoted on the Stock Exchange for the last five consecutive trading days immediately preceding the date of the Subscription Agreement; and a premium of approximately 3.83% over the closing price of HKD 2.48 per share as quoted on the Stock Exchange as of 02 October 2015. Net proceeds from the Subscription are estimated to be approximately HKD 513,550,000,and they will be used by the Company for financing mergers and acquisitions, capital expenditures, partial repayment of bank loans and for working capital and general corporate purposes.

Such transactions are considered on the basis of whether the transaction has been adequately explained and whether there is sufficient independent oversight of the recommended transaction. The circular contains full details of the transaction. Whilst there is insufficient independent representation on the Board, the Independent Board Committee comprising solely independent Non-Executive Directors, has determined the proposed transaction to be fair and reasonable. Triodos supports this resolution.
