4	Amend Articles: Procedures for Acquisition or Disposal of Assets It has been proposed to revise procedures for the acquisition or disposal of assets following the amendment of the R.O.C. Financial Supervisory Commission's regulations. The major revisions include: raising the disclosure threshold for acquisition or disposal of equipment for operation purpose with non-related parties from TWD 500 million to TWD 1 billion; and specifying the deadline for correcting any erroneous or incomplete disclosure as two days from the date the Company becomes aware of such error or incompleteness. The revisions in the procedures do not give rise to any major corporate governance concerns.	For
